Not much psyllid in Hemet, pretty low here, lots in Riverside.. Spoke with grower/land owner Hillestad-untreated-is going to remove all citrus from his property... .still working on website... will keep updating use reports from the last treatment period.
- d) Liaison reports.... Jason Schwartze is working on mapping unassigned groves in Valley Center \*more than 25 trees, but not on citrus gis layer... watching use reports come in from the last treatment. Bob talked about Tijuana HLB find. Mexico using root sampling, doesn't work very well. Mexico is only treating the area with 2 organic treatments/year. No conventional treatment. CDFA is wondering what to do in LA basin.... Step back and stop removing trees because it's expensive, or possibly increase tree removal because all the trees in the area were exposed. Right now LA basin is costing \$ 12M/yr, and not winning battle..... Dogs in Ventura locating trees with possibility of having HLB- many trees have been removed or bagged. Robert said CDFA will start treating near border soon.... Also said that there are 60 nurseries in the area with stock that will need to be destroyed if within an HLB quarantine.
