1. Financial Report:

Greg reports that all is going well and we are working on verifying treatments. Greg reports cash balance is good. Paul Kaymark gives a report on removing funds from LAIF and utilizing CLAS fund instead which will provide higher returns. The board approves Greg to start CLAS account after third quarter LAIF interest is paid at the end of October.

2. Manager Report

Enrico reports he attended the Ant workshop and was impressed with the research presentation. The new USDA 2EE approval of gel bait applications of Thiamethoxam is very welcome. He will contact the Ag Commissioners of San Diego and Riverside to see if growers can get an exemption to use it. Enrico reports the UC IPM site has changed the oil rates for organic treatments but still not enough for psyllid control. The board agrees to set our own limits. Also, to look into future research trials to determine effective minimum rates.

3. Liaison Report:

Sandra Zwaal reports HLB in San Diego County is now at 51 trees removed. Ventura now has 13 positive trees so far and quarantine includes 8600 growing acres and two packing houses. Sandra reports oriental fruit fly has been found

in Riverside and San Bernardino counties. Sandra reports she met the new scientist replacing Monique – Bodil Cass. Sandra reports Ops meeting is October 11th and full committee meeting November 8th in riverside.
